TYPES OF MEMBERSHIP

- Single Membership:** *Any person eighteen (18) years or over shall be eligible for single membership.*
- Double Membership:** *Any two (2) persons over the age of eighteen (18) residing at the same address shall be eligible for double membership.*
- Family Membership:** *A Family membership shall be for parent/s and bona fide dependent children up to eighteen (18) years of age. Grandparent/s and bona fide grandchildren up to eighteen (18) years of age and Official Guardians and children under the age of eighteen (18) years of age, such children shall be eligible for all the privileges of Junior membership.*
- Junior Membership:** *The Association may admit, as a Junior member, any person under eighteen (18) years of age, who owns or part owns a GSD, on payment of such subscription as the members, at a properly constituted General Meeting, shall decide. Junior members may not hold office nor vote at any General Meeting but may exercise such other privileges as are from time to time decided by the members at a properly constituted General Meeting.*
- Country Membership:** *Any person/s residing in excess of 50kms from the GPO Perth may be admitted as a Country member on payment of such subscription as the members at a properly constituted General Meeting shall decide.*
- Associate Membership:** *Any person may become an Associate member on payment of such subscription as the members at a properly constituted General Meeting shall decide. The privileges of Associate membership of the GSDA of WA (Inc) shall consist of the right to attend any General Meeting, as an observer only and subject to age constraints, (under eighteen (18) years of age), the right to compete as a Junior Handler in GSDA of WA (Inc) point score competitions.*
- Honorary Membership:** *Any person visiting this state who is a bona fide financial member of any other German Shepherd Association or Club or Council may be made an Honorary member of the Association and shall during such visit be granted all rights and privileges of a member except the right to hold office or vote at any Association meetings, provided that such membership be limited to eight (8) weeks. (Approval by any member of the Executive.)*
